***Accident & Injury:** I hereby certify that my child is in good physical condition and is able to participate fully in the programme / classes. I release **Balletomane Inc.** and its Artistic Faculty from any liability in the event of accident or injury.

***Attendance & Uniform:** I understand that attendance and uniform play major roles in my child's preparedness to learn and will do my utmost to ensure these practices. I will bring my child to classes regularly (with exception to illness) dressed and prepared.

***June Show:** I understand that the June Show will run from June 6th, 7th and 8th, 2019. My child may perform in one to four of the shows and **Balletomane Inc.** does not guarantee that all dance classes will perform in the same show.

***Promotional Materials Waiver:** **Balletomane Inc.** strives to showcase the achievements of our students whenever possible. I give permission to include photographs of my child in **Balletomane Inc.'s** newsletters, advertisements, promotional materials, social media platforms, and website for the purposes of illustrating the dance activities at **Balletomane Inc.**

***Cancellation Policy:** Fees are due as outlined by available payment options. Refunds will only be given in the case of severe illness or injury once classes have commenced (administration fee is not refundable). A minimum of 2 weeks' notice is required in writing if a student is to be withdrawn from a programme at which time postdated cheques will be returned. Students withdrawing from a programme after October 15th, 2018 will NOT be issued a refund – the remainder of fees for the school year will be due in full and payable to **Balletomane Inc.** – an additional cancellation fee of \$36 will be charged. I understand that this is a full year programme running from September 2018 to June 2019. This dance programme is not available on a term-by-term basis and I understand that my child will be dancing for the entire academic year from September 2018 to June 2019 – even if I cancel classes, I will pay for the full year of fees (subject to the withdrawal terms outlined above).

***Costumes:** I understand that each dance included in the June Junior Show and Senior Show will require a costume – costume prices will range from \$90 to \$160 per costume and a non-refundable costume deposit (\$60 per costume) will be due on October 15, 2018. I have left a postdated cheque for each dance number in the show at \$60 per costume. Alternatively, please charge my credit card (information above) in the amount of \$60 per costume for the June Show costume deposit on October 15, 2018.

***Video of Show:** I understand that all dances on stage in the June Junior and Senior Show will be recorded. For the 2018/19 dance season, the show will be filmed by Blue Toque Productions. When condensing the show footage to go onto a DVD, so much of the excellent resolution is lost, therefore, **Balletomane Inc.** will produce a digital file for distribution. **Balletomane Inc.** is delighted to be able to give you the best quality video of our show. This will be available through a link and access code to view the show and download your own digital copy. It is impossible to manage the ability of customers to share access codes – as such, each individual student of the school will be required to pay a \$25 fee for the video. This will be due on November 19, 2018. The link to the shows will be sent out in early August 2019. I have attached a postdated cheque or, alternatively, please charge my credit card (information above) in the amount of \$25 for the video of the June Show on November 19, 2018.
